## **Capital School District** Dover, DE

In Dover, Delaware, the Capital School District built a new state-of-the-art facility that served as a hub for two middle schools, totaling 205,000 square feet. Scheduled for completion in 2022, this project was designed by the renowned Becker Morgan Group and Perkins & Will architectural firms, with Richard Y. Johnson & Sons, Inc. overseeing construction management. The facility, with a total capacity of 1,600 students, connected the two middle schools through shared central facilities, including a gymnasium, auditorium, and cafeteria.
